#### MEETING MINUTES OF THE BOARD OF SELECTMEN

### **AUGUST 6, 2020**

A meeting of the North Haven Board of Selectmen was held on Thursday, August 6, 2020 at 7:00 p.m. in conference room #1 of the North Haven Memorial Town Hall, 18 Church Street, North Haven, CT.

Mr. Freda called the meeting to order at 7:03 pm and welcomed Selectman Pieper. Mr. Freda noted that Miss Buemi was unable to attend this evening. Mr. Freda and Mr. Pieper then proceeded in the recitation of the Pledge of Allegiance.

Mr. Pieper motioned with a second from Mr. Freda for the approval of the minutes of the Board of Selectmen's Meeting of July 2, 2020.

VOTE: Freda - yes; Pieper - yes

Mr. Freda provided remarks regarding the recent storm Isaias, the damage and the number of homes without power. He also advised that the Town's Field Operations Crews will be picking up storm debris curbside as well as offering residents a location where they may bring debris themselves. Mr. Pieper and Mr. Freda spoke for a short time regarding the Coronavirus pandemic.

The Director of Finance, Edward Swinkoski, is authorized to determine acceptable bid offers and/or take said vehicles to an alternate auction location.
