Mr. Alexander Wojtkowiak, Soil Scientist with William Kenny Associates, described the wetlands, water course, and plant species on the site.

Mr. Nicholas Granata, LEP with Tighe & Bond, discussed the remediation plan and stated that a ground water management plan has been drafted.

Mr. Steven Denino summarized the project for the proposed solar array and fencing.

Tenant, Michael Romano with Romano Landscaping, explained the materials stored on the site.

Owner, Maria DeAndra, spoke about paving.
