Project Narrative 110 Republic Drive December 8, 2020

The property at 110 Republic Drive is approximately 6.3 acres in size located in the IG-80 zone. Existing site improvements include and approximately 90,000 sf building consisting of predominantly warehouse/distribution uses with one automotive use as well as associated paved parking areas.

The applicant is seeking approval of a tenant to operate a beer distributor business. The operations will consist of an approximate 28,600 sf warehouse area. There will be no on-site sales of the beer or any type of alcoholic beverages. This tenant will replace an existing warehouse use of the same area. This use is allowed in the IG-80 zone and by Special Permit under Section 8.10, Sale of Alcoholic Liquor and Beer.
